## Zoning Change Approved for Lenox Place

At the August 17th City Commissioners' meeting, on motion of Candler Broom, the Commissioners unanimously approved a request by Lenox Place residents to downgrade their zoning from HDSF-1 (High Density Single Family) to R-60 (Single and Duplex Residential, the same as most of Winnona Park).

This area is located between Howard Avenue and Ponce de Leon, near the Decatur Post Office (see map on this page). It was initially composed of single family residences but had deteriorated over the years and was zoned in 1970 for high density single family building. However, the area has been "coming back" as a viable neighborhood during the last few years and this change in zoning is both a recognition of this fact and a victory for the Lenox Place Neighbors Association who organized the rezoning effort.

The neighborhood group had drawn up a petition requesting the change in zoning and it was signed by 135 of the 181 owners of single family residences in the area.

The petition was presented to a work session of the City Commissioners this spring and on motion of Candler Broom, it was referred to the Decatur Planning Commission. On August 6th, the Planning Commission unanimously recommended the change to the City Commission (Bill Breen abstaining). And, with a crowd of some 50 to 60 Lenox Place residents, Cathy Reader and Rick Huber (representatives of the Neighbors Association) presented the petition August 17th before the City Commission for final approval. With only slight opposition from a few developers, the City Commission voted unanimously to approve the change.







### COMMISSION NOTES

The work session preceding the July 20th meeting of the Decatur City Commission proved most interesting of the two. At that time the Commission again considered the possibilities of what to do with Beacon School. The highest sale offer of \$200,000 is less than the possible cost of \$400,000 to replace the gym for neighborhood use. The Commission decided that the best alternative would be to move the Police Department from its impossibly crowded present quarters into the old school building. Residents could continue to use the gym and craft rooms, and space would remain for other activities.

The Commission then decided to study a way to improve traffic flow on Church Street, possibly to include widening.

The official Commission meeting opened with the awarding of a service pin to Charles M. Gall, who has served as City Engineer for fifteen years.

The Commission then agreed to allow the subdivision of the lot located at 529 Adams Street (originally 3 lots) into two lots.

On the recommendation of the Housing Authority, the Commission voted on the continuation of the foreclosure prevention program. One person will handle this program and the rent subsidy program with 50 additional Section 8 housing units.

The 1980-81 budget was amended. Expenditures were up by 3% as a result of salary and fuel increases. Revenues increased by 10%.

Bids for three wheeled trash collector tires were awarded. The CCSD contract was amended to set terms for payment of proceeds from sale of two neighborhood centers which will relocate in SDCC.

Barbara Ramsey requested consideration to allow Trinity Head Start to move to Beacon School.


Norman Coffman requested support for the Cooperative Ministry's planned new resident information program at the work session preceding the August 3rd meeting.

Application for beer license for the Finch Mart at corner of College and McDonough was denied because of its closeness to Decatur High School.

The Associate Recorder's fee was increased from \$25.00 to \$30.00 per session.

Bids for Public Works uniforms were awarded and the meeting was adjourned.
